Thomas Braziel, as Receiver of Fund.com Inc. (“Company”), submits this brief in support of his motion to equitably disallow all nonpublicly traded Class A Shares in the Company, including unexchanged Class A Shares, or alternatively equitably subordinate all nonpublicly traded Class A Shares in right to payment to publicly traded Class A Shares.

BACKGROUND

I. THE RECEIVERSHIP PROCEEDING

The Company disclosed in its SEC filings that it had incurred indebtedness to entities (IP Global Investors Ltd., Equities Media Acquisition Corp Inc.) controlled by Jason Galanis (“Galanis”) pursuant to several loan agreements (“Loans”), and that the Company had also issued Preferred Shares, and two classes of common equity, Class A and Class B Shares. The Company also disclosed that the Class B Shareholder (initially Equities Media, and later Barry Feiner, Esq. as escrow agent) (*i.e.*, Galanis) controlled the Company.

The Company ceased its SEC reporting in 2010, after disclosing that the value of a supposed \$20 million CD that the Company was initially capitalized by, which CD converted to an annuity according to the SEC filings, had to be written down, and did not disclose what became of any of other assets it disclosed it claimed to have owned, including a 60% stake in ETF sponsor AdvisorShares Investments, LLC (“AdvisorShares”), or the fund.com domain name which the Company claimed to have purchased for \$10 million in 2007.

Notwithstanding the Company's having "gone dark" in 2010, following consummation of a 120:1 reverse stock split completed on September 27, 2010, the Company commenced a lawsuit against AdvisorShares in 2012, *Fund.com Inc. v. AdvisorShares Investments, LLC*, Index No. 650321/2012 (Sup. Ct. N.Y. Co.). That action was settled by Stipulation, entered October 27, 2015 (the "Settlement"). However, the Settlement was filed under seal. This receivership proceeding was commenced because the Company's supposed CEO, who admitted herein to being appointed by and proxy for Galanis (in an affidavit annexed to the Receiver's default judgment motion), and who signed the Settlement on behalf of the Company, refused to distribute proceeds of the same to shareholders, or even disclose its terms.

Following the Receiver's appointment on November 28, 2016, the Receiver obtained a copy of the Settlement, which provided for payments over time to the Company, less the Company's attorneys' one-third contingent fee.¹ The Receiver has now collected the outstanding payments.²

¹ The CEO also signed a payment instruction letter, directing the Company's attorneys to distribute the Settlement proceeds to Galanis, his criminal defense lawyers, and himself. That letter was revoked promptly upon the Receiver's appointment.

² AdvisorShares defaulted on its payment obligations to the receivership estate, under the Settlement. However, the balance of the Settlement was paid after the Receiver served restraining notices on Bank of America, thereby freezing AdvisorShares' bank accounts.

By order entered December 28, 2016, this Court established April 14, 2017 as the deadline for filing claims in this receivership proceeding. All claims that have been filed against the receivership estate have been disallowed.

By order entered April 24, 2017, this Court equitably subordinated, and in practical terms disallowed, Loan claims and all Preferred and Class B Shares, on the ground that they are believed to be owned by Galanis (or entities controlled by him), who used his control of the Company to perpetrate a pump-and-dump fraud on holders of publicly traded Class A Shares, and was since sentenced to fifteen years in Federal prison for orchestrating two separate fraudulent schemes. *U.S. v. Galanis*, No. 15-cr-643 (S.D.N.Y.) (Gerova, a \$20 million pump-and-dump fraud), No. 16-cr-371 (S.D.N.Y.) (tribal bond fraud, involving fraudulent issuance and placement of \$43 million in illiquid, sham bonds, and appropriation of the issuance's proceeds).

II. THE CLASS A SHARE REGISTRY

In contemplation of discontinuing the receivership, the Receiver reinitiated services with the Company's former stock transfer agent, Continental Stock Transfer & Trust, and requested a copy of the Class A Shareholder registry (the "Registry"). On July 19, 2018, a copy of the Registry as of such date was provided to the Receiver.

The Registry states 935,107 Class A shares are outstanding and lists twelve record holders.

The largest record holder is Cede & Co., which holds the 669,539 Class A Shares that trade publicly under ticker symbol FNDM. The balance of the Class A Shares are not publicly traded.

Seven record holders, listed as collectively holding 18,851 nonpublicly traded Class A Shares, are known fronts and/or associates of Galanis. They are: (1) Bevan Cooney (8,333 shares), who was indicted in the tribal bond fraud perpetrated by Galanis; (2) Meghann McEnroe (416 shares), Galanis's longtime assistant who is also listed in public records as an Officer of Equities Media and IP Global, which as noted above are vehicles through which Galanis perpetrated the Fund.com fraud; (3) Gregory Webster (1,458 shares), who served as the Company's CEO since March 11, 2008, just two months after it launched, and also served as a front for Galanis in the Fund.com fraud; and (4) several Westmoore entities that share the same address (8,644 shares), which entities served as vehicles through which Galanis perpetrated the Gerova fraud and which apparently operated an independent Ponzi scheme (*SEC v. Westmoore Mgmt. LLC, et al.*, No. 10-cv-849 (C.D. Cal.)).³

³ Three additional record holders are: Robert George, a chiropractor in La Jolla, California (<http://lajollasportandspine.com>) (64 shares), Gulfstream Capital LLC, Attn: Daniel D. White (1,250 shares), and Danny Palikrousis (4,166 shares). The Receiver has no record of any connection between these persons and the Company, based on his view of the Company's records. Moreover, no address is listed for Mr. Paokrousis (so no distribution could conceivably be made to him in any event) (same for Ms. McEnroe), and Daniel White is no longer a Gulfstream employee in any event.

The last record entry is one reserved for “unexchanged” shares that, for reasons unknown to the Receiver, were not swapped for new shares when the Company completed its 120:1 reverse stock split on September 27, 2010. Record holders of so-called unexchanged shares are listed on a separate tab in the Registry. Both tabs are attached to the accompanying Affidavit of Jeffrey Chubak as Exhibit 1 and Exhibit 2, respectively.

The vast majority of record holders of unexchanged Class A Shares hold just 100 such shares and so would not even qualify to own a single post-120:1 reverse split Class A Share. The Receiver has no record of any connection between any of these persons and the Company.

Thirty-three record holders are listed as owning more than 100 unexchanged Class A Shares, which holders collectively are listed as owning approximately 28.9 million pre-reverse split shares. The vast majority, however, likewise appear to be Galanis fronts or associates, and current addresses are lacking for the balance.

The largest record holder of unexchanged Class A Shares is “COS Capital Partners I LLC, c/o Huntley Family Investments LLC, Attn: Jason D. Huntley” (over 9 million unexchanged shares). Jason Huntley has a long history with Galanis, and he and Huntley Family Investments are listed as being involved in several Loan-related transactions in the Company’s SEC filings. In addition, according to SEC filings Mr. Huntley was to receive a “finders or origination fee” for services rendered

in connection with the Gerova fraud. He also stipulated to a five-year ban from the securities business on July 31, 2014 and pay \$100,000 in penalties in connection with separate frauds. Judgment was entered against him last year in the amount of \$100,000 for failing to pay the stipulated penalty (*SEC v. Huntley*, No. 17-cv-1939 (S.D. Cal.)).

The next largest holder of unexchanged Class A Shares is Lucas Mann (over 4 million shares). In addition to being identified in the Company's SEC filings as the Company's co-founder and Chief Marketing Officer, Mr. Mann was the co-manager of Thorsdale Fiduciary and Guaranty Company Ltd., which is described in the tribal bond fraud civil and criminal complaints as being yet another front for Galanis used in furtherance of said fraud. Thorsdale was also the entity that purported to have conveyed the fund.com domain name to Fund Alliance Corporation (n/k/a Distributed Finance Corporation), while that entity was controlled by Hugh Dunkerley, another Galanis front man named as a defendant in the tribal bond fraud action.

The next largest holder of unexchanged Class A Shares is GBC Wealth Management Ltd. (2.6 million shares), apparently an affiliate of Global Bank of Commerce (formerly Swiss American Offshore Bank), where the Company's \$20 million CD was purportedly on deposit. GBC Wealth Management Ltd. is also alleged to be an entity of which Gary Hirst is an officer, director, and major

shareholder, in an action brought by the Joint Official Liquidators of Wimbledon Financing Master Fund, Ltd. in New York County Supreme Court (*Wimbledon Financing Master Fund, Ltd. v. Weston Capital Mgmt.*, Index No. 653468/2015). Mr. Hirst is listed as a signatory in the Company's SEC filings on Loan-related documents. He was also sentenced to over six years in prison for his role in the Gerova fraud. A simple Google search reveals several other record holders are also linked to Hirst and/or the Gerova fraud, including: Taurus Global Opportunities Fund Ltd. (621,806 shares), Westmoore Holdings Inc. (2 million shares), Asia Capital Markets Ltd. (447,137 shares), Devermont Communications Ltd. (390,671 shares), and Pacific Rim Assurance Ltd. (c/o Sentinel Law Group) (370,000 shares) (owned by Jason's brother, Jared Galanis, who pled guilty to felony charges in the tribal bond fraud litigation, and was incarcerated).

Other record holders also have clearly documented links to Galanis, including: LH Capital Partners LLC (952,381 shares), c/o Jason Huntley (discussed above); Augustus Gardini LP (656,000 shares), c/o Steven Sugarman, the former Banc of California CEO who resigned when his links to Galanis became public; Recovery Capital Inc. (581,000 shares), c/o Matthew Jennings, the lead defendant in the SEC's action against Westmoore (*SEC v. Jennings*, No. 10-849-AG (C.D. Cal.), against whom a \$492,265 judgment was entered in favor of the Westmoore receiver; Milt Datsopoulos (no address listed, 500,000 shares), who also invested in another of

Galanis's companies, Incubator Capital;⁴ Whyte Lyon & Co. Inc. (300,000 shares), a purported Company subsidiary whose principal, Joseph Bianco, served with Galanis on the investment committee of Net Five Holdings LLC, a vehicle through which the Gerova fraud was perpetrated; DGM Bank & Trust (no address listed, 1 million shares), another offshore bank linked to Galanis frauds; and Barry Feiner Esq. as escrow agent (172,300 shares), and oft-utilized front for Galanis through which he held his Class B Shares according to the Company's last-filed Form 10-K.

Still other persons listed as holders of over 100 unexchanged shares have no address listed, are inactive/defunct, or are no longer located at their address of record. Holders with no address listed are: DGM Bank and Trust and Milt Datsopoulos (discussed above), Glenn Vellecillos, Kyle Washington, Angela Ho, Peter Kjaer, Jeff Wilson, Benny Behnen, Adam Hart, Loring Jacobs, Steve Weiss, and Dan Ha. Defunct record holders include: Power Plus Solutions Corp, (2 million shares), an entity whose status with the California Secretary of State is listed as "FTB Suspended" and whose license with the Arizona Registrar of Contractors was cancelled in 2014, and Sonata Multi-Manager Fund LP (1.25 million shares), an

investment advisor whose form ADV expired in 2013.⁵ Entities whose address of record in the Registry is invalid include: Redhawk Capital Management Inc. (1 million shares), which vacated from its address of record in the Registry years ago (that address is now occupied by a company named Terra-Gen, LLC); Emerging Market Global Hedge Ltd. (250,000 shares), the record address of which is a residential San Francisco apartment; and Nimish P. Patel (25,000 shares), The Turoci Firm (25,000 shares), Heather McDowell (20,000 shares), and Robert Hudson (10,000 shares), which based on the Receiver's investigation are not located at their record address as set forth in the Registry.

ARGUMENT

I. ALL NONPUBLICLY TRADED, INCLUDING UNEXCHANGED, CLASS A SHARES, SHOULD BE EQUITABLY DISALLOWED, OR ALTERNATIVELY, EQUITABLY SUBORDINATED IN RIGHT TO PAYMENT TO PUBLICLY TRADED CLASS A SHARES

All nonpublicly traded Class A Shares, including unexchanged Class A Shares, should be equitably disallowed or, alternatively, equitably subordinated in right to payment to publicly traded Class A Shares, for substantially the same reasons that this Court previously equitably subordinated, and in practical terms disallowed, the Loans and Class B and Preferred Shares believed to be owned by Galanis; namely, the Receiver has no record of shares having been paid for but rather the

shares appear to have been awarded by Galanis to his cronies, associates, and front men in connection with fraudulent schemes.⁶ Under these circumstances, equitable disallowance or, alternatively equitable subordination, is warranted under principles articulated by the United States Supreme Court in *Pepper v. Litton*, 308 U.S. 295, 306-07 (1939), which acknowledges that “disallowance or subordination” of a stockholder’s interests in a corporation is permitted, pursuant to “cardinal principles of equity jurisprudence,” depending on “whether or not under all the circumstances the transaction [acquisition of stock] carries the earmarks of an arm’s length bargain. If it does not, equity will set it aside...” This result is particularly appropriate where, as here, “the history of the corporation shows dominancy and exploitation on the part of the [dominant stockholder],” and the Company “has been used merely as a corporate pocket of the dominant stockholder [Galanis] who, with disregard of the substance or form of corporate management, has treated its affairs as his own.” *Id.* at 308-09.

Commentators agree that *Pepper v. Litton* permits disallowance of claims or interests in the name of equitable subordination. *See, e.g.*, David Gray Carlson in

⁶ The Receiver lacks knowledge as to whether that is the case with respect to record holders of unexchanged Class A Shares that are listed as holding 100 shares, but those shares would not be entitled to a single post-split Class A Share in any event. The Receiver also lacks knowledge with respect to record holders of unexchanged Class A Shares with no address, or an invalid address, or defunct record holders; however, no distribution can be made to them in any event.

The Logical Structure of Fraudulent Transfers and Equitable Subordination, 45 WM. & MARY L. REV. 157, 201 (2004) (“In *Pepper*, the Court permitted complete disallowance of X’s claim, an act the *Pepper* Court called subordination. The legislative history to the Bankruptcy Code specifically endorses the disallowance remedy as a mode of equitable subordination”), citing H.R. Rep. No. 595, 95th Cong., 1st Sess. 359 (1977) (“Nor does this subsection [section 510(c), which codifies *Pepper v. Litton*] preclude a bankruptcy court from completely disallowing a claim [or interest] in appropriate circumstances”); *id.* at 210 (“the Supreme Court [found] *res judicata* [to be] no impediment to disallowance of X’s claim under the name of equitable subordination”).

Although *Pepper v. Litton* was a bankruptcy case, the Supreme Court made clear the doctrine is rooted in state law, and applies in receivership proceedings. As noted by Professor Carlson:

A close examination of *Pepper v. Litton* shows that the Supreme Court relied at least in part on state law in constructing the federal doctrine of equitable subordination. The reliance on state law antecedents strongly suggests that the Supreme Court viewed equitable subordination as already implicit in the state law at the time ...

The Court ... emphasize[d] that equitable subordination was simply the ordinary exercise of equity powers. Equity is not limited to bankruptcy proceedings and so the Court conceived that it was simply adapting nonbankruptcy law to the context of bankruptcy liquidations.

In further explaining the doctrine of equitable subordination, the *Pepper* Court wrote: “The applicable principal is that, where a

corporation is so organized and controlled as to make it a mere instrumentality or adjunct of another, and the subsidiary becomes bankrupt, the parent corporation cannot have its claim paid until all other claims are first satisfied....” Immediately following this remark, Justice Douglas added: “The same result has been reached in equity receiverships.” At least after Erie, equity receiverships arise under state, not federal, law. Hence, the Supreme Court itself recognized that the doctrine of equitable subordination was founded on state law principles.

Id. at 212-16 (emphasis added).

NOTICE

Notice of the Receiver’s moving papers has been served on the record holders of nonpublicly traded Class A Shares, at the address set forth in the Registry (if any).

CONCLUSION

Based on the foregoing, the Receiver requests entry of an order disallowing all nonpublicly traded Class A Shares in the Company, including unexchanged Class A Shares or, alternatively, equitably subordinating all nonpublicly traded Class A Shares in right to payment to publicly traded Class A Shares, and granting such other and further relief as is just and equitable.


