# **RULE 151(1)-(2) INVENTORY AND LIST**

Pursuant to Chancery Rule 151(1)-(2), Thomas Braziel, as receiver (the "Receiver") of Fund.com Inc. (the "Company"), by and through his undersigned counsel, submits the following inventory of Company property and list of debtors and creditors of the Company, showing all debts due to/from the Company and their respective addresses:

# **INVENTORY**

<u>Cash</u>: Checking account funded with \$10,211.01 payment from David Berke from approximately \$200,000 in AdvisorShares settlement proceeds he previously paid to himself.

<u>Investments</u>: The Company stated in its SEC filings that it holds a 100% ownership interest in the following entities: Vensure Employer Services, Inc., Weston Capital Management, LLC, and Whyte Lyon Socratic Inc. The Company

also stated it holds an interest in National Holdings Corporation. The value of the foregoing interests is unknown.

CD/Annuity: The Company stated it owned a \$20 million CD held at an Antiguan bank in its initial SEC filings, but later stated the CD was converted to an annuity issued by an insurance company located in the British Virgin Islands, and that the annuity may have to be written down by \$15 million and that the Company's financial statements would have to be restated (which restatement never occurred). The Receiver believes this asset is fictitious but lists it out of an abundance of caution.

Causes of Action: The Receiver believes he has potential claims and causes of action against, among others, (1) Jason Galanis, (2) two companies through which he controlled the Company, Equities Media Acquisition Corp. Inc. and IP Global Investors, Ltd., (3) Robert Levin and David Berke, purported sole directors and officers of the Company, (4) Murphy, Pearson, Bradley & Feeney, Inc., a Professional Corporation, and certain of its attorneys that aided and abetted Galanis's breach of fiduciary duty and conversion of the fund.com domain name and other domain names (collectively, the "URLs") in or about April 2014, which domain name (fund.com) the Company represented it purchased for \$10 million, <sup>1</sup>

(5) one or more entities controlled by Brett Klein and/or Ronald Lieberman of NorthStar Asset Management Group Inc. which purchased the URL from Galanis in a private sale, and (6) former directors and officers of the Company. The value of these causes of action is unknown.

<u>Insurance Policies</u>. The Company owns two claims made D&O insurance liability policies issued by Liberty Insurance Underwriters Inc. with policy periods of Jan. 31, 2010-11, and Jan. 31, 2011-12. Each has a liability limit of \$5 million per policy period. The policy numbers are D03H755228002 and D03H755228003, respectively.

AdvisorShares Investments, LLC: Pursuant to a Confidential Settlement Agreement and So-Ordered Stipulation, so ordered by Justice Anil Singh on October 26, 2015, AdvisorShares agreed to pay the Company an agreed amount spread over multiple installments. Two installment payments totaling \$2.5 million have yet to be made, and are therefore owing together with interest on the same that accrues at the rate of 6% per annum. (Form 8-Ks, Sept. 3, 2009, Jan. 26, 2010.) The Company also stated it borrowed an additional \$1 million from IP Global pursuant to another loan agreement, dated July 27, 2010. (Form 8-K, July 30, 2010.) IP Global asserted in a demand letter to David Berke, dated February 29, 2016, that it

is owed over \$8,627,390.02 under the foregoing agreements. This claim is disputed by the Receiver.
